


STRIP-PET

Underlayment stripping - Preparing subfloor for installation of new covering. Save preparation time, remove excess mastics, adhesives, rubber or foam backings - strip away felt, paper, jute, etc. Use in kitchens, rec-rooms, bathrooms, patios, basements, balconies - use on wood, plastic or concrete surfaces.

OPERATING PROCEDURES

Remove old floor covering material - we suggest using the EDCO UNI-RAM - 5 foot long, air operated scaler - it eliminates bending or working on your knees - faster than a tile stripper and much more efficient.

STRIP-PET is NOT designed to strip tile, linoleum, or carpet. STRIP-PET will remove the glued-down backing material, adhesives or mastics.

Check surface for protruding nails, inserts, screws or staples - remove or set below floor surface.


USING THE STRIP-PET

The STRIP-PET is built to operate on standard 115 volt AC power. Note - check motor plate for specific electrical specifications and information. STRIP-PET models for use in foreign countries will have electrical motors designed for the country in which they will be used. Always include model number and serial number when inquiring about your STRIP-PET.

The STRIP-PET electric motor is a special, slow speed design, 1 H.P. (13.4 amps). Use on standard 15 amp grounded circuit.

To start - position STRIP-PET on sub-floor surface. A slight pressure down - on the handle will raise cutters from direct contact with floor surface and allow motor to reach operating speed when switch lever ("A") is squeezed. Lower STRIP-PET slowly on to it's operating position and move it across the surface slowly. Always allow the motor to run at full speed - jamming cutters into backing material will cause motor to run slow or stall, overheating will cause circuit breaker to trip eventually burn out will occur.

The weight of STRIP-PET will keep it set at the proper depth. If an exceptionally hard or stubborn deposit is encountered, pushing down on the handle will tilt the cutter assembly up and away from the trouble spot. You can then gently lower the cutters on top of the problem area allowing the cutters to run at full speed cutting away the problem deposits. Releasing the switch lever will stop the motor instantly.






Check cutting height adjustment set-screw ("B"). Top of screw should measure (2-1/8") from floor surface. Adjust if necessary - always lock the adjustment screw with locking nut to prevent the cutting height from changing during the stripping operation.

Swivel Caster

The rear swivel caster ("D") has also been factory set. It's position (Figure #2) is important to the proper operation of the STRIP-PET. After setting the height adjustment set screw ("B") - Check the swivel caster height ("D"). Measure from floor surface to bottom of welded nut. Set and lock in position as indicated in (figure #2). DO NOT change this setting unless you specifically want to tilt the cutterhead down for more aggressive cut. Adjusting the caster may cause the front edge of the cutter assembly to penetrate into the subfloor, cutting and damaging the surface. The STRIP-PET is designed to produce an even, uniform, clean cut.

Allow the STRIP-PET to come to rest on top of the adjustment set screw ("B"). All strip-fingers should be in contact with floor surface evenly. See Fig. 6.



Strip-fingers may be adjusted individually if they are not in floor contact. Loosen the screw holding the strip finger ("E"), allow the finger to slide down until it rests on the surface - retighten the screw securely.

Follow the above procedure when replacing strip-fingers that are worn out or damaged.


It is important that the cutting height be set according to instructions. Cutters set too low will damage your sub-floor, cutters set too high will not remove all the backing material.

If you prefer, you may remove the strip-fingers from the cutter head for sharpening - be sure to replace and align them according to the instructions provided.

The STRIP-PET cutterhead consists of a set of counter rotating, heavy steel hubs on to which the strip-fingers are attached. Standing in the operators position - the left cutter hub turns counter-clockwise - the right hub turns clockwise. Strip-fingers are attached in six positions on each hub. When replacing strip-fingers always install finger so that the cutting edge is facing in the direction of rotation. (Figure # 4). When ordering strip-fingers - order in sets of 12 (6 left and 6 right) or when single cutter is ordered be sure to specify right or left.

For proper operation the cutting heads must be flat against the floor surface or just slightly above it. The tungsten-carbide must be kept sharp on two edges (Figure # 7). A "green" wheel is used for this purpose. Fingers can be removed from the machine for sharpening or a hand-held grinder used to touch up (hone) the edges without removing cutters from the machine.

Sharpen the bottom of the carbide at approximately 6° angle. This angle will change as the finger wears - the object is to keep the carbide flat against the floor. The outside edge of the carbide should also be kept sharp - this edge cuts and "peels" the surface material away. (Figure # 8).





TRANSPORT


The STRIP-PET can be moved easily to and from and around the job-site.

A handle latch lever, (Figure #10) located on the lower right side of the gear case, positioned just behind the right wheel will lock the handle into the transport position. To activate push the handle down until it reaches a position parallel with the floor. The latch will automatically lock the handle in the horizontal position. Lift handle and the STRIP-PET will be raised on to the rolling wheels - similar to using a hand truck.

To release - lower handle to the horizontal position again - lift latch to unlock - the handle can now be raised and the STRIP-PET will be ready for use - refer to (Figure # 9).

Handles are attached to the gear case to aid in loading and unloading from vehicles or on to work sites.

Since mastics and adhesives tend to heat up when being removed - we suggest wrapping the wheels with duct tape and removing the tape at the end of the job to keep the wheels clean and free rolling.



READ AND FOLLOW OPERATING INSTRUCTIONS

1. Use only on a grounded three wire circuit.

2. Check electric motor specification plate.

3. Match incoming power to motor specifications - do not exceed motor specifications.

4. Use only three wire approved cord - refer to diagram for length and wire size.

5. Do not use frayed or damaged electrical extension cords.

6. Keep electrical cord from contact with cutters - it can cut through the insulation and cause injury or death.

7. Always unplug STRIP-PET when sharpening cutters or performing other repairs.

8. Keep all protective guards in place when unit is in use.

9. Keep feet and fingers away from all moving or rotating parts.

10. Keep loose material off floor and away from rotating cutter assembly to prevent accidental contact, (plastic sheeting, cords, etc.).

11. Keep unauthorized, untrained subjects away from operating equipment.

12. Be sure to tag damaged or improperly operating equipment and DO NOT use until repaired.






ILLUSTRATION 2: MOTOR & SWITCH ASSEMBLY
